The candidate's primary objective is to provide strategic guidance and management of MHC's granting programs, including approximately \$11M in annual funding through the Conservation Trust, GROW Trust, Wetlands GROW Trust and the Fish and Wildlife Enhancement Fund.

As the Grants Manager, you will:

- Supervise and manage the MHC Trust team.
- In consultation with the CEO and the leadership team, develop annual budgets and oversee annual program plans for the Trusts.
- Oversee annual granting cycles to ensure that priority activities are delivered, and milestones are achieved as per annual work plans.
 - Key areas of activity overseen include, but are not limited to:
 - Application processes that are efficient and consistent with the purposes of the Trusts and the MHC strategic plan.
 - o Internal and external technical review processes for applications.
 - o Grant award recommendations for review and approval by the MHC Board.
 - o Criteria and templates for contribution agreement and grantee reporting.
 - Guidelines for review of interim and final reports of projects, including monitoring/auditing of the same.
 - Structured reporting of grants program outputs and outcomes as required within MHC and to external stakeholders.
 - Internal and external communications in support of the Trusts granting programs.
 Ensure a framework for Trusts granting decisions that is focused on priority outcomes, aligns with current scientific knowledge and is consistent with objectives established for the trusts.
- Adapt and implement evaluation protocols that aggregate project outputs and translate them into conservation outcomes that can be assessed against the purposes of the Trusts and reported to partners and the public.
